d. Synergistic activities.

- 1. I have had published more than 500 works, including more than 350 journal articles, 50 book chapters, and 5 books. Five more books (2 Sage and 3 Routledge) are in progress.
- 2. My h-index is 94 and my g-index is 251. My articles have been cited in more than 65,000 works.
- I have delivered more than 50 keynote addresses at regional, national, and international conferences, including delivering a lecture for the Edgar W. Couper Lecture Series in May 2018
- 4. I have made more than 1,000 presentations worldwide.
- 5. My articles have been published in prestigious journals such as *The Lancet*, *Educational Researcher*, *American Educational Research Journal*, and *Educational Administration Quarterly*.
- 6. I am former editor of *Educational Researcher* (flagship journal of the American Educational Research Association [AERA]). I am current Editor-in-Chief of the *International Journal of Multiple Research Approaches* and Co-Editor of *Research in the Schools* (since 2003).
- 7. I have secured more than 30 grant awards.
